Approval of Minutes

Review Design Review Board Recommendation

Application to install solar panels on the existing single-family dwelling at 4 N. Avalon Road. The Design Review Board recommended disapproval of the application, citing a lack of symmetry in the proposed layout of the solar panels. Kevin Orlando of Long Island Power Solutions (contractor) presented an alternate layout for the solar panels located on the front roof of the dwelling.

The general consensus of the Board was that the alternate arrangement was an improvement from the prior layout. Daniel Hom, owner of 4 N. Avalon Road was in agreement with the Mr. Orlando's proposed change.

The Mayor suggested that the plan showing the revised layout of the panels be presented to the Design Review Board at their next meeting on February 23, 2023 at 7:00 p.m. The contractor and the homeowner agreed to return to Design Review Board on February 23, 2023.

Sale of 2015 Autocar/Schwarze A7 Street Sweeper

The Deputy Mayor reported that the 2015 Autocar/Schwarze A7 Street Sweeper (the "2015 Sweeper"), VIN 516M1DB26FH219067, was placed on the online auction site, GovDeals.com, with the winning bid subject to the approval of the Board of Trustees. The auction closed with a high bid of \$85,000.
